PROPOSAL

for a Council Regulation (EEC, ECSC, Euratom) No ... adjusting daily subsistence allowance rates for officials on mission, laid down in Article 13(9) of Annex VII of the Staff Regulations of Officials of the European Communities.

THE COUNCIL OF THE EUROPEAN COMMUNITIES

Having regard to the Treaty establishing a Single Council and a Single Commission of the European Communities,

Having regard to the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Communities as laid down in Regulation (EEC, Euratom, ECSC) No 259/68¹ last amended by Regulation (Euratom, ECSC, EEC) No 2998/75², and in particular Article 13 of Annex VII to these Staff Regulations, and Articles 22 and 67 of the said Conditions of Employment,

Having regard to the proposal from the Commission,

Whereas it appears advisable in view of the increased costs observed to adjust the rates of daily subsistence allowance for officials on mission;

Whereas it is for the Council, acting on a proposal from the Commission, to adjust the rates laid down in Article 13 of Annex VII of the Staff Regulations of Officials of the European Communities in accordance with the procedure laid down therein,

HAS ADOPTED THIS REGULATION:

Article 1

With effect from 1 October 1976 the rates laid down in Article 13(9) of Annex VII of the Statute shall be adjusted as follows:

1. The increases contained in paras. 1, 3 and 8 of Article 13 shall be replaced by the following:

50% for missions to Paris

40% for missions to Germany, Belgium, Denmark, Luxembourg and the Netherlands
30% for missions to Strasbourg

25% for missions to France, except for Paris and for Strasbourg

10% for missions to the United Kingdom and Ireland

5% for missions to Italy.

2. The increases contained in para 2 shall be replaced by the following:

35% for missions to Paris

30% for missions to Germany

20% for missions to the Netherlands and to Strasbourg

15% for missions to Belgium and France, except for Paris and for Strasbourg, and to Luxembourg
10% for missions to Denmark

5% for missions to Italy.

Article 2

This Regulation shall enter into force on the day following publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
