THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Communities laid down by Regulation (EEC, Euratom, ECSC) No 259/68¹, as last amended by Regulation (EEC, Euratom, ECSC) No 1601/75², and in particular Article 94 of the Conditions of Employment;

Having regard to the proposal from the Commission;

Whereas, by Regulation No 11/65/Euratom³, as last amended by Regulation (Euratom) No 1908/75⁴, the Council laid down the conditions governing remuneration and social security for establishment staff of the Joint Research Centre employed in the Netherlands;

Whereas the changes made in August 1975 in the salaries of the staff of Reactor Centrum Nederland justify a further amendment of Regulation No 11/65/Euratom for the benefit of the establishment staff of the Joint Research Centre employed in the Netherlands,

HAS ADOPTED THIS REGULATION:

Article 1

Article 3d of Regulation No 11/65/Euratom is repealed with effect from 1 August 1975.

Article 3e is renumbered Article 3d.

Article 2

There is added to Regulation No 11/65/Euratom the following Article 3e:
"For each month of service completed during the period from 1 January to 31 July 1975, establishment staff shall receive a single allowance amounting to 3.2% of the aggregate of the basic monthly salary for July 1975 plus 13% of the basic salary plus rent allowance. The single allowance may not be less than Fl 40 gross per month."

Article 3

The Annex to Regulation No 11/65/Euratom is replaced by the following with effect from 1 August 1975:
