

#### REPORT TO THE COUNCIL

In accordance with the provisions of Article 99 of the Staff Regulations, the appointing authority has granted, for 1984, bonuses for exceptional service to certain officials and temporary staff who occupy a post in the field of nuclear science calling for scientific or technical qualifications and who are paid from research and investment appropriations. The unit value of the bonus is Bfrs 50 000.

The recipients have been selected on the following criteria:

- (a) outstanding work, usually published (excluding patented and exploited inventions, which are covered by Article 94 of the Staff Regulations);
- (b) high-level performance (sustained efforts in connection with experiments and various studies);
- (c) exemplary behaviour in special circumstances (industrial accident, fire, contamination).

The figures in the three tables attached specify:

#### Annex I

The amount, total number and number by grade of recipient of the bonuses awarded, giving a breakdown by Establishment and department.

#### Annex II

- 1. The amount of the bonuses paid, compared with basic salaries in 1984.
- 2. The number of officials and temporary staff classed as scientific or technical staff at 31 May 1984 and the number of officials and temporary staff who received bonuses.
- 3. The above two items expressed as percentages.

#### Annex III

Number of recipients of bonuses, by category and selection criterion.

The Commission draws particular attention to the fact that it has kept within the limits fixed in the Staff Regulations for the aggregate and individual amount of the bonuses awarded. The regulation limit for the aggregate amount is 3% of total basic salaries paid to scientific and technical staff, and the actual figure for 1984 is 0.1677%. The regulation limit for unit value is three times the amount of the basic monthly salary.

#### STATISTICS

1. The basic salaries paid to scientific and technical staff for 1984 amounted to approximately Bfrs 3 165 413 608.

The bonuses awarded for exceptional services totalled Bfrs 4 550 000 (budget allocation: 118 000 ECU, or Bfrs 5 308 702 at the December 1984 rate).

2. 1950 officials and temporary staff were classed as scientific or technical staff on 31 May 1984.

65 officials were awarded a bonus. These were 44 one-unit, 16 two-unit, and 5 three-unit bonuses.

- 3. The above figures show that:
  - . 3.33% of staff were awarded an exceptional-service bonus;
  - . the bonuses awarded represent 0.1677% of the total basic salaries paid during the year.
