

REPORT TO THE COUNCIL

Under Articles 56a and 56b of the Staff Regulations, special allowances may be granted for certain services of a special nature to officials or other staff (a) paid from research and investment appropriations and assigned to a Joint Research Centre Establishment or an indirect action or (b) paid from operational appropriations.

The criteria for granting allowances to officials or other staff required to do shiftwork or to remain on stand-by duty at their place of work or at home are set out in Article 1 of Council Regulation No 300/76 of 9 February 1976 and Article 1 of Council Regulation No 495/77 of 8 March 1977.

The allowance granted for shiftwork is calculated at a flat rate, varies according to the nature of the service performed and is adjusted by the weighting applicable to the official's salary. (Until 31 January 1976 the shiftwork allowance was calculated on the basis of a points system.)

The allowance granted for stand-by duty is calculated on the basis of a points system:

for stand-by duty at place of work: 11 points an hour on working days and 22 points an hour on Saturdays, Sundays and public holidays;

for stand-by duty at home: 2.15 points an hour on working days and 4.3 points an hour on Saturdays, Sundays and public holidays.

Article 1 of Regulation No 495/77 specifies that a point is equal to 0.032% of the basic salary of an official in Grade D4, first step, the allowance being adjusted by the weighting applicable to the official's remuneration.

This report, the first presented since the new Regulations entered into force, covers the 1977 financial year. In future the annual report will be drawn up in April of each year and relate to the previous financial year. A comprehensive report for the 1978 and 1979 financial years will be presented in due course.

The annexed tables give the following information:

Annexes I to IV

show the number of officials and other staff in each category in each JRC Establishment who received a special allowance in 1977, plus total expenditure relating to each allowance. The amounts indicated are greater than those shown in the revenue and expenditure account, as the latter do not include the weighting.

Annex V

gives the same information for indirect actions. The discrepancy between the budgetary charging and the breakdown of expenditure in respect of Items 1183 and 1184 (based on applications for allowances) is due to the fact that the computer programme for staff salaries only provides one code for these allowances originally payable under Regulation No 1371/72 but now payable under two separate Regulations (Nos 300/76 and 495/77).
