EXPLANATORY NOTE

A derogation to the origin rule in Protocol No 3 to the Free Trade Agreements with the EFTA-countries for certain products in tariff heading 38.19 was introduced in 1976 by Joint Committee Decision.

This derogation, valid for the period 1 December 1976 - 30 November 1977, was made necessary by a change in the international economic conditions at the time which gave rise to the possibility that the products in question would lose originating status even though the processes of manufacture remained unchanged.

These economic conditions persist and it is therefore necessary to extend the derogation until 31 December 1978, after which date no further extention is foreseen.

This is the reason for the seven proposals for Joint Committee Decisions which should be adopted as the common Community position.

For simplicity and for reasons of urgency the draft Regulations to apply these Decisions are also being submitted at the same time for approval.

JOINT COMMITTEE DECISION No /77

derogating from List A annexed to Protocol No 3 concerning the definition of the concept of 'originating products' and methods of administrative cooperation

THE JOINT COMMITTEE,

Having regard to Protocol No 3 concerning the definition of the concept of 'originating products' and methods of administrative co-operation, and in particular Article 28 thereof,

Whereas the provisions in List A annexed to Protocol No 3, as amended by Joint Committee Decision No 2/76⁽¹⁾, only apply until 30 November 1977 in the case of certain products falling within tariff heading No 38.19;

Whereas, since the international economic conditions that led to the introduction of these provisions for the products in question continue to exist, the period of validity of these provisions should be extended until 31 December 1978,

HAS DECIDED AS FOLLOWS :

Article 1.

By way of derogation from the special provisions applying to tariff heading No ex 38. in Annex II to Protocol No 3, the products listed in column 2 below shall be considered as originating products in(C) or the Community provided that both the conditions in column 4 and the other conditions of Protocol No applicable to these products are satisfied.
