EXPLANATORY MEMORANDUM

The International Council for the Exploration of the Sea advises that fishing for mackerel should be prohibited each year in the period 1 January to 30 April and from 1 November to 31 December in the ICES division VIa north of 58°00' N in order to protect the "eastern" stock of mackerel when it migrates into this area.

Article 7 of Council Regulation (EEC) N° 172/83 (1) in conjunction with Council Regulation (EEC) 198/83 (2) prohibits fishing for this species in this area from 1 March 1983 to 30 April 1983 and 1 November 1983 to 31 December 1983.

The proposed regulation has the objective of minimising the effects of the closure on the activities of the fleets. As the "eastern" stock of mackerel is less abundant in the area in November than during the rest of the period recommended by ICES, it will have minimal effects on the conservation of the stock.

PROPOSAL FOR A
COUNCIL REGULATION (EEC)

altering the conditions of fishing for mackerel

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community.

Having regard to Council Regulation (EEC) N°170/83 of 25 January 1983 establishing a Community system for the conservation and management of fishery resources (1), and in particular Article 11 thereof,

Having regard to the proposal from the Commission,

Whereas fishing for mackerel in part of ICES division VIa is prohibited from 1 March to 30 April and from 1 November to 31 December, according to Regulation (EEC) N° 198/83 (2), in conjunction with Article 7 of Regulation (EEC) N° 172/83 (3), until such time as the Council takes a decision on the Commission's proposals concerning TACs and quotas and the conditions of fishing applicable in 1983;

Whereas, having regard to scientific advice obtained, the period during which fishing for mackerel should be prohibited should be amended;

HAS ADOPTED THIS REGULATION :

Article 1

By derogation from Article 1 of Regulation (EEC) N° 198/83 and Article 7 of Regulation (EEC) N° 172/83 fishing for mackerel shall be prohibited in ICES division VIa north of parallel 58°00' N from 1 to 31 December 1983.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

It shall apply with effect from 1 November 1983.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
