EXPLANATORY MEMORANDUM

At its first Annual Meeting on 7 June 1979 the General Council of the Northwest Atlantic Fisheries Organization adopted amendments to Annex III of the Convention on Future Multilateral Cooperation in the Northwest Atlantic Fisheries, pursuant to Article XX, paragraph 2 of the same Convention.

These amendments affect the delimitation of the boundary between the statistical subareas covering the waters between the West coast of Greenland and the coast of Canada. Corresponding changes should be made to the text of the Convention as it appears in Council Regulation (EEC) No 3179/78.

Proposal for a Council Regulation

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Communities, and in particular Article 103 thereof,

Having regard to Council Regulation (EEC) No 3179/78 of 28 December 1978 concerning the conclusion by the European Economic Community of the Convention on Future Multilateral Cooperation in the Northwest Atlantic Fisheries (1),

Having regard to the proposal from the Commission,

Whereas on 7 June 1979 the General Council of the Northwest Atlantic Fisheries Organization adopted with effect from 1 January 1980 amendments to Annex III of the Convention on Future Multilateral Cooperation in the Northwest Atlantic Fisheries, pursuant to Article XX, paragraph 2 of the same Convention, concerning the delimitation of the boundary between the statistical subareas covering the waters between the West coast of Greenland and the coast of Canada;

Whereas it is appropriate that the Community amend the text of the Convention as it appears in Regulation (EEC) No 3179/78;

Whereas having regard to the above-mentioned date it is necessary to adopt this Regulation as an interim measure on the basis of Article 103 of the Treaty, subject to it being included at a later date in the common agricultural policy,

HAS ADOPTED THIS REGULATION:

Article 1

Paragraphs 1(a) and 2(a) of Annex III to the Convention on Future Multilateral Cooperation in the Northwest Atlantic Fisheries, published in the annex of Regulation (EEG) No 3179/78, shall be amended as shown in the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall apply until it is replaced by a Regulation adopted under Article 43 of the Treaty, but in any case not beyond 31 December 1980.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

1.- Paragraph 1(a) of Annex III to the Convention shall read as follows:

" 1 (a) Subarea 0

That portion of the Convention Area bounded on the south by a line extending due east from a point at $61^{\circ}00'$ north latitude and $65^{\circ}00'$ west longitude to a point at $61^{\circ}00'$ north latitude and $59^{\circ}00'$ west longitude, thence in a south-easterly direction along a rhumb line to a point at $60^{\circ}12'$ north latitude and $57^{\circ}13'$ west longitude; thence bounded on the east by a series of geodesic lines joining the following points:

and thence due north to the parallel of 78°10' north latitude; and bounded on the west by a line beginning at 61°00' north latitude and 65°00' west longitude and extending in a northwesterly direction along a rhumb line to the coast of Baffin Island at East Bluff (61°55' north latitude and 66°20' west longitude), and thence in a northerly direction along the coast of Baffin Island, Bylot Island, Devon Island and Ellesmere Island and following the meridian of 80° west longitude in the waters between those islands to 78°10' north latitude; and bounded on the north by the parallel of 78°10' north latitude."

2. Paragraph 2(a) of Annex III to the Convention shall read as follows:

2 (a) Subarea 1

That portion of the Convention Area lying to the east of Subarea 0 and to the north and east of a rhumb line joining a point at $60^{\circ}12'$ north latitude and $57^{\circ}13'$ west longitude with a point at $52^{\circ}15'$ north latitude and $42^{\circ}00'$ west longitude.
